Speakers	<b>Colin J WALL</b>	<b>Trustee of and past President of the Chartered Institute of Arbitrators, Accredited Mediator (HKIAC), Chartered Surveyor, Chartered Arbitrator, FCI Arb (Arbitration and Mediation)</b> Professor Wall has been appointed as Arbitrator on over 50 occasions, including conducting many oral hearings of various durations and document only arbitrations and issuing numerous awards, none of which have been successfully challenged. Arbitrations have been conducted on an ad-hoc or institutional appointment basis for both domestic and international disputes. Disputes arbitrated mainly relate to building, civil engineering and process engineering matters as well as general commercial disputes. Professor Wall has also been mediating disputes for over 20 years both domestically and internationally. He is a past Chairman of the Hong Kong Mediation Council and also runs a mediation training company.
	<b>David FONG Shiu man</b>	<b>Director of JMHO, Accredited Mediator (HKIAC), Listed Arbitrator (HKIAC), Panel Arbitrator (KLRCA), FCI Arb (Arbitration), FCPA</b> Mr. Fong was appointed as arbitrator on 3 occasions and acted as representative of parties in 5 international arbitrations held in China, Hong Kong and Singapore (both institute-administrated and ad hoc) Mr. Fong is a sub-committee member of Commercial Mediation Interest, Hong Kong Mediation Council and was appointed as a mediator in more than 10 occasions. The disputes include sales of goods, insurance claims, money due & owing, breach of contract.
