- Background** The Hong Kong Mortgage Corporation Limited ("HKMC") launched the [SME Financing Guarantee Scheme](#) ("Scheme") (中小企融資擔保計劃) in January 2011. The Scheme aims to help small and medium-sized enterprises and non-listed enterprises obtain loans from participating lenders such as banks for meeting their business needs so as to enhance their productivity and competitiveness in the rapidly changing business environment. Under the Scheme, the HKMC will provide guarantee coverage on 50%, 60% or 70% of the loans to eligible enterprises.
