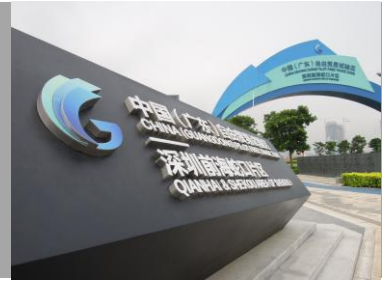




Mainland Business Interest Group – Cocktail Reception

Dr. Hung is the president of Internet Professional Association and the executive chairman of Chinese Big Data Society. He is an investor for technology start-ups and has worked in the computer industry for 28 years. He has extensive experience in management consulting, project management and outsourcing services. He is a Chartered Information Technology Professional and a fellow member of the British Computer Society, the Chartered Management Institute U.K., the Hong Kong Institute of Directors, the Hong Kong Computer Society and the Internet Professional Association. He has been appointed as director by World Summit Awards in 2015 and an eminent expert representing Hong Kong and China since 2011.

Dr. Hung is currently the vice chairman of China Overseas Friendship Association's Youth Committee and the Monte Jade Science and Technology Association of HK, member of the Ningxia Chinese People's Political Consultative Conference, the Shenzhen Chinese People's Political Consultative Conference, and the Chinese Association of Hong Kong and Macau Studies, vice president of Guangdong's Association for Promotion of Cooperation between Guangdong, Hong Kong & Macao, chairman of Hong Kong Road Safety Association, Honourary Chairman of the Y.Elites Association, secretary general of Hong Kong-ASEAN Economic Cooperation Foundation, Council member of Hong Kong Professionals and Senior Executives Association and research fellow of PanGoal Institution etc.

Dr. Hung was appointed as the Justice of the Peace by the Hong Kong SAR Government in 2015 and has served as a part-time (associate) member of the Central Policy Unit of the government during 2012 and 2014. He was the 11th Standing Member of the All China Youth Federation. In 2012, he was awarded as one of the Capital Entrepreneurs of the year. In 2011, he was given the award of 40+ Distinguish Fellow. In 2008, he was given the Award of Ten Outstanding Young Persons of Hong Kong.
